### 3. Approval of last meeting's minutes.

### 4. Presidents Opening comments.

- President thanked Gary and Steve for recent work over the past 3-4 months.
- June 5th meeting received positive feedback from golfers for smooth execution.
- Emphasis on keeping meetings brief and efficient.
- Sponsorships: 4 new lined up, goal is 12; discussion on value and tracking.
- Coordinate Website Update, JD, Pat, and Marion to meet and update the website; Pat to eventually take over backend responsibilities.
- Aggressive Sponsorship Outreach, After website update, get aggressive with sponsorships; goal is 12 sponsors.
- Obtain Foursome Certificates, JD to try to get certificates for foursomes to play as sponsor incentives.
- Add Golf Genius to SOP, Coordinate with Irene or relevant person to update

operating procedures to include Golf Genius positions.

- Divot Filling Initiative, Organize and communicate the August start of divot filling, ensuring it is voluntary and well-supplied. Teams go out 20 minutes early on thursdays. check-in staff not involved in divot filling. Bermuda grass can regrow with sand and moisture in summer; seed not necessary in refill jars, except in winter.
- Finalize and launch the new website in ~3 weeks, roll out advertising packages, and provide analytics to sponsors.
- Venue changed:
  - Lee Fair's request; six golfers unavailable Tuesday mornings.
  - Charlene could not find available rooms at Desert Vista for 3:00 PM.
  - Alternative venues suggested: Summit at Pinnacle, Mountain Shadow.
  - Plan to seek quieter venue for August meeting.
- JT agreed to collect cash for event on 7/24/25

## **5. Tournament chair & event recap.**

- Tournament Planning and Formats
  - Tournament formats set through end of July.
  - Next special event: Labor Day, two-man Pinehurst format.
- Tournament Details, Hole-in-One, and Handicaps:
  - Discussion focused on whether to exclude short holes (e.g., #17 at 106 yards, #3 at 115 yards) from the hole-in-one pot due to perceived fairness.
  - Decision postponed; tees expected to reopen in 2-3 weeks, so no immediate changes planned.
  - Questions raised about whether to also remove closest-to-the-pin and adjust handicaps for affected holes.
  - Arguments presented for keeping all holes eligible, citing the inherent difficulty of achieving a hole-in-one regardless of distance.
  - Motion proposed to either include all holes or exclude all from the hole-in-one pot, with no final decision reached.
- Questions were raised with no confirmation on whether or not the “beat the pros” tournament was still viable.
- Tournament Logistics, Team Sizes for 7/3/25 Thursday :
  - 65% of handicap being used, no drive minimum.
  - Tournament scheduled with 89 players: 17 foursomes, 7 threesomes.
  - Proposal to use shamble format for threesomes, adjusting team structure as needed.
  - Tees: Gold players use red, gold, white; others use red, white, blue.
  - Current sign-ups: 4 threesomes, 5 twosomes, 3 singles; tracking player splits.
  - Skins game offered as optional participation.
  - Agreement to let threesomes compete against threesomes, foursomes against foursomes.
  - Sign-up deadline enforced; late sign-ups may not guarantee a spot.

## **6. Special events.**

- Clarify Gratuity Distribution, 20% gratuity already included in food pricing. Ask Marvin about the distribution of the 20% gratuity to ensure it reaches the appropriate staff. Pertains to using a tip jar.

- Tony moved to Morningstar assisted living; unlikely to return soon. Tony's eyesight is improving but still cannot read the newspaper; focusing on balance and eyesight recovery. Tony has been a major sponsor for the club. JD and JT assumed Tony's responsibilities to avoid inconsistencies in sponsor contacts.

- Jay assigned to collect food money from attendees at July 3rd tournament. (\$25 per player) Menu includes hot dogs, hamburgers, chicken, coleslaw, potato salad, beer.

## **7. Treasurer's report & Financials.**

- Checking Acc: 5,321.75
- Savings: 6,920.22
- COH: 323
- Total cash: 12,564.97
- No invoicing system needed due to small budget.
- Confirmed: all four sponsors are paid and current.
- Event fee increased from \$10 to \$15; catering cost is \$18 per person, creating a \$3 deficit per attendee.
- Treasurer's report approved by motion and vote.

## **8. Handicap Report.**

- Suspensions: Two members, with end dates noted. Golfer # 1 (ends July 10), Golfer #2 (ends July 17), Golfer # 2 reduced his handicap by 2.5 strokes through frequent score postings.

## **9. Webmaster Report.**

- Coordinate with Marion on Website Backend

Work with Marion and Pat to ensure backend and database systems are understood and accessible.

## **10. Rules Report.**

- Don needs new members sent to him upon signup by Dan.

## **11. Golf genius.**

- Golf Genius Procedures and SOP Updates:
  - Requested addition of Golf Genius positions (Steve, Jerry) to operating procedures.
  - Uncertainty about how to access and edit operating procedures (SOP).
  - Suggested contacting person maintaining SOP; Irene Cudins mentioned as possible contact.
- Website Development and Golf Genius Trial.

- Golf Genius offered a free one-month trial for score input feature.

Purpose was to evaluate potential purchase of the premium program. Club decided not to purchase; feature discontinued. Only one SCS club showed interest; proposal voted down by others.

## **12. Old Business.**

- - 65% of handicaps used for this week per USGA guidelines.
- Tee box corrections made; red tees assigned to holes 1, 4, 7, and 10.
- Skins collection scheduled; substitute needed for July 24th.
- Pro shops continue to provide new members with informational booklets.

## **13. New Business.**

- Advertising packages for new website presented and discussed
- New Business: Advertising Packages and Website Launch
  - Current advertising sponsorship lacks tracking of sponsor benefits.
  - Currently 4 sponsors; goal is 12 sponsors.
  - Legal approval obtained for advertising and golf cart promotions.
  - New website launching in ~3 weeks with dedicated advertising strip.
  - Advertising packages: Starter (\$400/year, 150 unique visits), Silver (includes in-ground signs), Gold (\$1,500, cart display), Diamond (\$2,200, insurance for hole-in-one prize).
  - Analytics and QR codes included for tracking ad performance and engagement.
  - Need to follow up with Shane on providing foursome certificates to sponsors as incentives.
